

A GUIDE TO VISA APPLICATION PROCESS.

APPLYING FOR E-VISA TO TRAVEL IN GEORGIA CONSISTS OF TWO PARTS

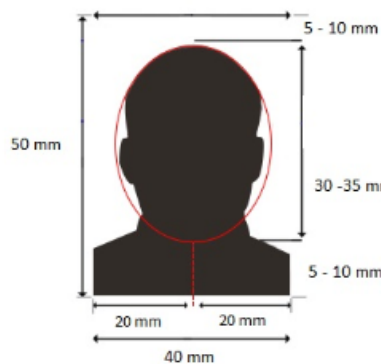
FIRST PART DOCUMENTATION

1. UPLOADING PERSONAL INFORMATION, SUCH AS COPY OF PASSPORT- MUST BE PDF OF AND MUST HAVE BOTH OF THE PAGES OF PASSPORT
2. UPLOADING ISO/ICAO STANDARD PHOTO – NO SMILE WITH TEETH, STILL PHOTO WITH BELOW MENTIONED REQUIREMENTS:

Georgian e_Visa Photo Requirements:



- Recent Photo taken within 6 months
- Studio photo only
- No selfie / No scan photo are allowed
- Full face, front view, eyes open
- No head covering (except for Religion reason)
- Eyeglasses may be worn, but there must not be any glare
- White Background
- No Border / Frame

Attention! Your e_Visa may be rejected if the requirements are not met

3. CHECKING THAT YOU HAVE A VALID TRAVEL INSURANCE – WILL NEED ON THE BOARDER

SECOND PART DOCUMENTATION

1. AADHAR CARD NUMBER- AFTER INSERTING THE NUMBER IN THE SYSTEM, OTP WILL BE SENT TO THE CLIENT WHICH IS A 6 DIGIT CODE AND MUST BE SENT TO US PROMPTLY SINCE IT HAS A SHORT VALIDITY TIME. SO BEFORE SENDING AADHAR OTP, COMMUNICATION WITH THE CLIENT IS MUST.
2. PAN CARD NUMBER AND THE PASSWORD THAT THE CLIENT USES TO LOG IN THE PAN SYSTEM. <https://eportal.incometax.gov.in/iec/foservices/#/login> - THIS IS THE SYSTEM WHICH'S PASSWORD I REQUIRED. IF THE CLIENT DO NOT REMEMBER IT, THEY CAN HIT "RECOVER" AND SEND US PROMPTLY. THIS IS ADDITIONAL SCORE IN THE VISA ASSESMENT PROCESS.
3. BANK STATEMENT OF THE LAST SIX MONTH- STATEMENT MUST BE IN THE PDF FORM, MUST NOT BE SCANNED DOCUMENT. BANKS ISSUE A DOCUMENT WHICH IS SYSTEM GENERATED AND IT IS ABSOLUTELY ENOUGH. NO SCANNED BANK STATEMENT ACCEPTED BY THE SYSTEM.

Do's and Don'ts for Submitting Bank Statements:

Do's

- Submit in PDF Format.
- Upload the original, uncompressed files exactly as provided by your bank via email or internet banking.
- Provide the password for the PDF if any. It is safe to do so.
- Upload multiple bank statements if required.
- Bank statements must cover the past 6 months period.

Don'ts:

- Do NOT submit Excel or CSV format.
 - Do NOT Compress the PDF file.
 - Do NOT alter or tamper the PDF file.
 - Do NOT use any PDF altering tool.
 - Do NOT try to remove the password from your PDF File. Provide the password in field. It's safe.
 - Do NOT submit documents covering less than 6 months.
4. SUPPORTING DOCUMENTS- Marriage Certificate, Birth Certificate, Company Leave Letter, Company Appointment Letter, Company Bank Statement, Invitation Letter, Sponsor Letter, Event Ticket or Registration, Old Passport Copy, Visa in Old Passport, Single Parent Declaration for Minor, Salary Slip. You can only upload upto 10 documents.

DOCUMENTS THE TRAVELER NEEDS ON THE BOARDER ALONG WITH THE ABOVE-MENTIONED ONES:

- TRAVEL INSURANCE
- TAX RETURN ACKNOWLEDGMENT
- HOTEL RESERVATION TICKET
- ROUND TRIP TICKETS
- FINANCIAL STATEMENTS
