Terms And Conditions For Visitors

- The visitor or his/her representative must reach to the Forest permit booking counter to collect the boarding pass, at least 45 minutes prior to the entry time.
- First visitor whose photo I'd uploaded, is mandatory to visit the park so that I'd of that tourist can be checked.
- The Id proof of visitor produced at the time of collecting boarding pass should be the Id used while booking online permit, failing which, the permit will be deemed fake and liable to be cancelled. The visitors must carry original I'd/ digi locker I'd during visit.
- The charges deposited during online booking include tourist entry fee, tiger reserve development fund, vehicle entry fee, vehicle rent, guide fees and online booking charges and applicable taxes.
- The visitor must bring two copies of confirmation slip at the time of collecting boarding pass. One copy will be deposited in the office and the other copy will be carried by the visitor.
- Seats remaining vacant due to non-turn up of any visitors would be filled by the park management at the booking window.
- The time to receive the boarding pass will start two hours before the park entry time.
- In order to avoid fake bookings, a restriction of booking maximum 6 seats in single transaction has been made.
- In case of group booking, park authorities will try to adjust the group together in vehicles subject to space availability at the time of entry.

If visitor cancel a permit then-

- a. 75% refund booking amount if cancellation is made before 31 and more days from the date of visit.
 - b. 50% refund of booking amount if cancellation is made before 4-30 days from the date of visit.
 - c. 0% refund of booking amount if cancellation is made with in 3 days from the date of visit.
- In case of any changes in applicable Fees & Tax Rates, the difference amount shall be collected at the time of Boarding/ entry of the park
- In case the passengers are less than the capacity of the vehicle then the difference of vehicle rent and guide fee applicable uniformly per person will be charged extra.

The following conditions of the indemnity bond have been agreed by the visitors at the time of booking of this permit: The visitors hereby stated that he/she/they is/are aware of the risks involved in visiting the Ranthambhore / Sariska Tiger Reserve/ Other protected area/ Forest area. He/she/they further stated that he/she/they is/ are entering the area at his/her / their own risk and he/she/they shall be fully liable if any accident occurs. He/she/they is / are fully satisfied with the security arrangement made by the protected

- area/ forest area management and he/she/they is/ are also responsible for damage to his/her/their belonging's (Life, Camera, binocular, video camera etc.) he/she/they is/are informed that in case of any unforeseen accident the protected area/ forest area management shall not be responsible in any manner whatsoever. He/she/they, also agreed that should thereby need of any litigation the same would be enable only in a court of law in the state of Rajasthan. He/she/they submitted the indemnity bond with full consciousness.
- The visitors should produce all documents required as per COVID19 guidelines issued from time to time like valid RTPCR Test report, proof of 2 doses of vaccination, etc
- Visitors under the influence of alcohol or intoxicating substances will be denied entry to the park, and may face legal consequences as per Forest Department regulations.
