01 DAY: Arrival & Budhanilkantha Temple:

Arrival at Kathmandu airport then transfer to hotel. Upon arrival at the hotel, welcome with soft drinks and check-in. Lunch at the Hotel. After lunch, visit Budhanilkantha Temple (Jal Narayan Temple) and return to the hotel. Overnight, stay at a hotel.

02 DAY: After Breakfast, Proceed For Local Sightseeing Drive to Chandragiri Hills Via Swoyambhunath Stupa:

Pashupatinath Temple (Which belongs to Lord Shiva)

After Breakfast heading to the Chandragiri Cable Car Station, located just outside Kathmandu, for your journey up to Chandragiri Hills. Enjoy a scenic cable car ride to the top of Chandragiri Hills (2,540 meters above sea level). The ride lasts around 12-15 minutes, providing breathtaking views of the Kathmandu Valley and, on clear days, the Himalayas, including Mount Everest. Visit Bhaleshwor Mahadev Temple (A temple dedicated to Lord Shiva with a spiritual atmosphere). Enjoy lunch at one of the restaurants at the top of Chandragiri Hill or the base station restaurant after descending via the cable car. After Lunch Drive to Swoyambhunath Stupa. One of Kathmandu’s most iconic landmarks, Swoyambhunath Stupa is a UNESCO World Heritage Site and offers stunning views of the Kathmandu Valley. exploring this ancient stupa, which is sacred to both Buddhists and Hindus. After Sightseeing Drive back to the Hotel.

DAY 03: Departure:

Start your day early with the stunning sunrise over the Himalayas. Nagarkot is famous for its panoramic view of peaks like Mount Everest, Langtang, and Dhaulagiri on clear days. After Breakfast depart for International Airport. Pick up from the hotel 3 and half hours before your flight time as you need to reach the airport 3 hours early to your flight time.

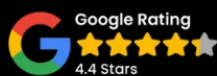
## Cancellation Policy
