TOURISM TAX ACT 2017

Effective 01 September 2017, Tourism Tax 2017 is applicable to all guests except Malaysians and Malaysian Permanent Residents (MyKad & MyPR Holders).

RM10.00 per room, per night will be collected in accordance to the Tourism Tax Bill 2017.

LANGKAWI TOURISM FEE

An additional fee of RM5.00 per room per night will be collected in accordance to the Local Government Act 1976 on behalf of the Langkawi Municipal Council for all guests.

PENANG TOURISM FEE

Effective 1 June 2014, the Penang state government has introduced a mandatory tax of RM2 per room per night for all hotels in Penang.

This tax is payable upon arrival or departure at the hotel and is not included in the room rate. PAHANG TOURISM FEE
